24/123. Scrambler Bikes

This has been an issue for over seven years in the village with residents feeling intimidated and being verbally abused. The Parish Council has over this time tried all avenues to try and stop the noise, nuisance and dangerous parking from the bikes.

The land owner has recently been served a Community Protection Warning (CPW) from Halton Borough Council (HBC), this has been issued for a three-week period. HBC has asked for statements, dates and noise recordings from residents. If conditions aren't met by the land owner, a Community Protection Notice (CPN) can be issued.

The review date will be the 6th March 2025. Highways and Planning will also be informed.

Noted Cllr D A Cairns will arrange a resident meeting in Daresbury Village Hall to discuss incidents and collate evidence.
